



Number of Lancaster County Residents that Meet Risky Prescribing Metric Criteria




Total Number of Prescriptions by Drug Class for Lancaster County Residents

Percent of Opioid Prescriptions, by Sex: Quarter 4, 2021






Rate of Suspected <u>Any Drug Overdose</u> Emergency Department Visits per 10,000 Population



Any Drug Overdose includes overdoses of any substance, including over-the-counter, prescription and illicit drugs.




Rate of Suspected <u>Any Opioid Overdose</u> Emergency Department Visits per 10,000 Population



Any Opioid Overdose includes overdoses of any opioid substance, including prescription and illicit opiates, such as heroin and illicitly manufactured fentanyl.




Rate of Suspected Drug Overdose Emergency Department Visits per 10,000 Population, by Age



Any Drug Overdose includes overdoses of any substance, including over-the-counter, prescription and illicit drugs.




Rate of Suspected Drug Overdose Emergency Department Visits per 10,000 Population, by Sex





Lancaster County Residents' Rate per 10,000 Population of Drug Overdose Deaths by Sex, 2017-2021*





Lancaster County Residents' Rate per 10,000 Population of Drug Overdose Deaths by Age Group, 2017-2021*





Lancaster County Residents' Rate per 10,000 Population of Drug Overdose Deaths by Race, 2017-2021*




